



MEMORANDUM OF UNDERSTANDING

BETWEEN

HOCHSCHULE FÜR WIRTSCHAFTUND RECHT (HWR) Berlin, GERMANY Department for Cooperative Studies

AND

NATIONAL UNIVERSITY ZAPORIZHZHIA POLYTECHNIC (NU ZAPORIZHZHIA POLYTECHNIC)

Zaporizhzhia, UKRAINE

Hochschule für Wirtschaft und Recht Berlin (HWR Berlin) and National University Zaporizhzhia Polytechnic (NU Zaporizhzhia Polytechnic) have agreed to establish collaborative relations between the two institutions. The purpose of this agreement is to promote academic exchange programs and co-operation in research and education and to increase the mutual understanding between the two institutions and both countries. The parties to the contract recognize to have full legal capacity to formalize the following agreement.

The institutions have agreed that:

- The two institutions shall encourage co-operation in any discipline which is studied in both institutions.
- Both institutions will encourage the following activities in academic and educational fields in which they have mutual interest:
 - (1) Joint research
 - (2) Faculty exchange
 - (3) Student exchange at undergraduate and/or graduate level
 - (4) Development of double or joint programmes
 - (5) Exchange of research results, academic publications and other academic information
 - (6) Other academic exchange upon which both institutions agree.

Details of any such activities will be subject to a separate Agreement that will be attached to this as an annexure.

- The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this Agreement, and shall consult from time to time at the request of either institution for the purpose of reviewing the operation of this Agreement.
- The financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program of co-operation. Both sides agree that they will not place financial burdens on each other.
- The Agreement shall become operative on the date of the last signature indicated hereunder and shall remain in force for a period of three years with an option to renew for another three years.
- This Agreement may be amended and supplemented by agreement between the two institutions. Amendments and or supplements will be appended as an annexure.
- Either institution may terminate this Agreement by giving six months' notice in writing to the other institution. Any projects, training, or exchanges that may have commenced at either institution before the date of termination may be completed by special agreement be-tween the two institutions. For conditions not covered by this Agreement, or for problems that arise during the course of this Agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.
- The institutions shall confer concerning the renewal of this Memorandum of Understanding six months prior to the date of expiration.
